## TITLE OF THE PAPER TIMES NEW ROMAN 14

**ABSTRACT:** The Abstract in English language and Summary in Serbian language should be a short and informative presentation of the article. Abstract may have from 100 to 250 words. Abstract should be typed in Times New Roman 10. Summary written in Serbian language can be 1/10 length of the article and should contain the title of the article, first, middle initial, and last names of the authors, authors' institutional affiliation and address, and key words.

**KEY WORDS:** up to 10 key alphabetically listed key words, separated by commas, typed in Times New Roman 10, may be listed

### 1. INTRODUCTION

Type the manuscripts electronically on A4 (21 x 29.5 cm) format with 2.5 cm margins, first line indent, and 1.5 line spacing using the provided template. When writing the text and titles, the authors should use Times New Roman size 12 font and when writing the abstract, key words, summary, and footnotes use font size 10.

First name, middle initial and last name should be given for all authors of the manuscript and their institutional affiliations, institution name, and mailing address. In complex organizations, a full hierarchy should be mentioned (e.g. University of Novi Sad,

Faculty of Sciences - Department of Biology and Ecology). The institution of employment of each author should be stated below the author's name. The position and academic degrees should not be cited. If there is more than one author, indicate separately institutional affiliation for each of the authors. Put the name and mailing address (postal or e-mail address) of the author responsible for correspondence at the bottom of the first page. If there is more than one author, write the address of only one author, usually the first one.

Original articles should not be longer than 10 pages, including the references, tables, legends, and figures. Review articles should not be longer than 12 pages, including references, tables, legends, and figures. Write brief communication according to the instructions for original articles but not be longer than five pages.

Titles should be informative and not longer than 10 words. It is in the best interest of the authors and the journal to use words in titles suitable for indexing and electronic searching of the article.

The references in the text should be cited as in the following example (Xyzxcv et al., 200X). References in the text should include author's last name and the year of publishing. When there are two authors both should be cited, but in case of three or more authors, cite the first author only and follow with et al. If two or more articles of the same author or authors published in the same year are cited, designate the publishing years with letters a, b, c, etc., both in text and reference list. The names of the periodicals should be abbreviated according the instructions in the Bibliographic Guide for Authors and Editors (BIOSIS, Chemical Abstracts Service, and Engineering Index, Inc.). Do not translate references to the language of the article. Write the names of cited national periodicals in their original, shortened form. For example, for the reference in Serbian language, put (Sr) at the end of the reference. Leave 1 blank line between sections (e.g. Introduction, Materials and Methods, Results, ...).

## 2. MATERIALS AND METHODS

All sections should be numbered. Section titles should be written in capital fonts with font size 12.

### 2.1 Units, Names, Formulas, Figures and Tables

Sections of the paper may be divided into subsections. If these are present, they should be marked as follows: 1.1., 1.2., etc.

SI units of measurement (Systeme international d'unites) should be used but when necessary use other officially accepted units. Write the names of living organisms in Latin using Italics font style. Abbreviated form of a term should be put into parenthesis after the full name of the term first time it appears in the text. Chemical formulas and complex equations should be drawn and prepared for photographic reproduction.

Tables and figures can be either incorporated in the text or given after the text of the paper. In the latter case please mark the desired position of figures and tables in the text. Number the tables using Arabic numerals. Above each table, write a caption with table explanation as in Tab 1.

Authors may use black-and-white photographs and good quality drawings. A caption with the explanation should be put below each figure as in Fig. 1.

### 3. RESULTS AND DISCUSSION

Results and discussion may also be presented in separate sections, written in Times New Roman 12. The article should be written and submitted using this provided Microsoft Word file template. Submission should be made to the Editorial office of the Matica Srpska Journal for Natural Sciences via email to [vnikolic@maticasrpska.org.rs](mailto:vnikolic@maticasrpska.org.rs). After the acceptance of the article, send a final version of the manuscript in Microsoft Word and PDF format to facilitate technical processing of the text. Before printing, the manuscripts shall be sent to the authors for the approval of final version. Corrections of the text prepared for printing should be restricted to misspelling and printing errors as much as possible. For major changes of the text, a fee will be charged. Corrected manuscript should be returned to the Editorial office as soon as possible.

#### 4. CONCLUSION

Write the information about financial support, advices, and other forms of assistance, if necessary, at the end of the article under the Acknowledgement. Financial support acknowledgement should contain the name and the number of the project, i.e. the name of the program from which the article originated, and the name of the institution that provided the financial support. In case of other forms of assistance the author should submit the first name, middle initial, last name, institutional affiliation, and the address of the person providing the assistance or the full name and the address of the assisting institution.

#### ACKNOWLEDGEMENT

Title of the Acknowledgement section should also be written in capital letters with font size 12. The same applies for the title of the section of References found below. References should be listed alphabetically. References themselves should be written with fontsize 10.
